SUBMIT APPLICATION

Submit your completed application with all required documents through your CIT Education agent or our online application portal at **international.cit.edu.au**

A LoO will be emailed to you along with information on:

- Course fees and duration
- Overseas Student Health Cover

ACCEPT OFFER

Submit all required documents, signed Acceptance Form (LoO) and signed visa requirements form through our online application portal.

CONFIRMATION OF ENROLMENT (COE)



Once payment has been confirmed, you will be sent the CoE by email along with information on:

- Your Overseas Student
- Health Cover policy
- Orientation Day information
- Things to know before moving to Canberra
- **Unique Student Identifier (USI)** information

THERE ARE TWO WAYS YOU CAN APPLY TO STUDY AT CIT:



APPLY THROUGH A CIT EDUCATIONAL AGENT

CIT Educational Agents are located in countries throughout the world. They are official representatives for CIT and can help you apply for your chosen course in Canberra.

They offer support and advice about studying at CIT and living in Canberra and will assist you with your visa and study applications, plus your English language testing requirements.

They also maintain contact directly with CIT on your behalf, making the application process easier for you.



APPLY ONLINE

Once you have confirmation that you're able to apply to CIT directly you can apply online through international.cit.edu.au/apply

Please ensure that you have ALL your supporting documentation prepared before you start.

These documents should include your passport, academic results and completion certificates, English test results, a GTE Statement, your curriculum vitae, birth certificate, etc.

Ensure that all documents are translated into English.
